In the matter of: Tariff Petition No.1 of 2022 (TANGEDCO), Tariff Petition No.2 of 2022 (TANTRANSOCO), Tariff Petition No.1 of 2020 (SLDC) and M.P.36 of 2022 (Non-Tariff related Miscellaneous Charges) – Comments from the stakeholders.

1. Tariff petitions filed by the TANGEDCO, TANTRANSOCO and SLDC have been admitted and numbered by the Commission as T.P.1 of 2022, T.P.2 of 2022 and T.P.1 of 2020 respectively. The Petition for determination of Non-Tariff related miscellaneous charges (M.P.36 of 2022) was also admitted by the Commission on the same date. In the Daily Order dated 19.07.2022, Commission directed the Licensees, to host the Tariff petitions in their websites.
2. Adhering the provisions of Conduct of Business Regulations, the Commission allowed a time period of thirty days to the stakeholders to furnish their comments on the above Petitions. Stakeholders have been asked to furnish the comments on or before 17.08.2022. In this connection, Commission has received 169 comments so far (within 22 days). Though many stakeholders have furnished their comments on the Tariff petitions within this time, few of them have sought to extend the time for submission of their comments considering the high volume of data.
3. Though a reasonable time period of thirty days already been given, taking into consideration of time extension sought by those consumers, and with the

public interest in mind, the Commission hereby extends the time period by seven days for submission of comments by the stakeholders i.e., upto 24.08.2022.

4. Further, the Commission would like to state that any stakeholder who is unable to furnish the comments to the Commission through Postal / Courier / email service, may furnish the view / comments before the Commission during the Public hearing to be held at the following places: –
