Malarvizhi, Director (Finance) of TANGEDCO appeared as directed by this Commission in the previous hearing. When enquired in regard to non-compliance of the order by TANGEDCO, the Director (Finance) stated that due to financial crunch, the order could not be complied with and that part payment of Rs.15.7 crore has been made in obedience to the direction of the Hon'ble Commission. Further, she prayed that TANGEDCO may be permitted to pay the admitted dues in monthly instalment. The learned counsel for the petitioner while vehemently opposing ordering payment in instalments prayed for passing stringent orders on TANGEDCO and its officials as there is deliberate flagrant non-compliance of the orders of the Commission and as the amount due is a whopping 102 crores. The Director (Finance) stated that there is

dispute as to the quantum payable by TANGEDCO. Submissions made on either side and written submissions of the petitioner considered. The Commission directs both parties to undertake reconciliation process with regard to the amount owed by TANGEDCO to the petitioner and file a memo in this regard on 02.05.2024. In the interregnum, TANGEDCO is directed to make payment of Rs.20 crore to the petitioner in the 3rd week of April 2024. The request of TANGEDCO to pay the amounts due in instalments will be considered on 02.05.2024 on the basis of memo filed with regard to the amounts due. For verification of compliance of the above directions, matter adjourned to 02.05.2024.
