Order:

The Chairman, Tamil Nadu Electricity Board has sent a proposal to the Government requesting that the court of sessions may be specified as special courts for speedy trial of Offences under section 135 to 139 of the Electricity Act, 2003 for theft of energy. The proposal was examined in consultation with the Registrar General, High Court, Chennal. The Registrar General, High Court has recommended for constitution of Special Courts for speedy trial of offences under sections 135 to 139 of the said Act. including at Chennal and Madural and requested that necessary notification may be issued.

2. The following Notification will be published in the Tamil Nadu Government Gazette Extraordinary dated the 5th October 2006.

NOTIFICATION

In exercise of the powers conferred by sub-sections (1) and (2) of section 153 of the Electricity Act, 2003 (Central Act 36 of 2003), the Governor of Tamil Nadu, with the concurrence of the High Court, Chennai, hereby constitutes the Court of Sessions specified in column (3) of the Table below to be the Special Court for the purposes of providing speedy trial of offences under sections 135 to 139 of the said Act within the Jurisdiction comprising of the Sessions Division, specified in column (4) in respect of the districts specified in column (2) thereof.



ORDER:-

The Registrar General, High Court, Chennai in his letter 3rd read above has stated that consequent on the Revenue bifurcation of Chengalpattu District and formation of new Revenue District at Tiruvallur, the Government have issued orders for the constitution of separate District and Sessions Court and Chief Judicial Magistrate Court at Tiruvallur for Tiruvallur District and the said Courts are functioning with effect from 03.11.2006. In view of the constitution of separate District Court and Chief Judicial Magistrate Court at Tiruvallur and the existing District and Sessions Court and Chief Judicial Magistrate Court at Chengalpattu have been redesignated as Kancheepuram District. In view of the above position, necessary powers to the Principal District Court, Tiruvallur for trial of offence under, Sections 135 to 139 of Electricity Act 2003, has to be conferred.



issued in the Government Order first read above, so as to include sections 135 to 140 and 150 of the said Act in the preamble portion of the Notification issued in the said Government Order. He has also stated that the Districts that have been left out in the said Government Order and that are in need of Special Courts are Thiruvarur, Krishnagiri and Ariyalur Districts and therefore Special Courts have to be constituted in the above Districts.

- 4) In the letter fourth read above, the Registrar General, High Court. Madras has stated that consequent on the bifurcation of Nagapatinam and formation of Thiruvarur District, the Government in the Government Order fifth read above, have issued orders for constitution of District and Sessions Court at Thiruvarur and the said court is functioning w.e.f 20.09.2008. Further, consequent on the bifurcation of Dharmapuri District and formation of Krishnagiri District, the Government in the Government Order sixth read above, have issued orders for constitution of District and Sessions Court at Dharmapuri District and the Chief Judicial Magistrate Court No.II, Krishnagiri and the said court is functioning w.e.f 17.2.2008.
- 5) The Government after careful examination, issue the following amendment to G.O. Ms. No.102, Energy (B1) Department, dated 5.10.06 and the same will be published in the <u>Tamil Nadu Government Gazette</u>.
