ORDER:

In exercise of the powers conferred by sub-section (6) of section 17 of the Electricity Regulatory Commissions Act, 1998 (Central Act 14 of 1998) and on the recommendation of the Selection Committee constituted under section 18 of the said Act, orders were issued in the Government order first read above appointing Thiru E.C.Arunachelem, as Member of the Tamil Nadu Electricity Regulatory Commission. He assumed office on 1.7,1999 and retired on 15.12.2002.

2. Consequent on the enactment of the Electricity Act, 2003 (Central Act 36 of 2003), the Government of Tamil Nadu in the order second read above constituted a Selection Committee under section 85 (1) of the said Act in order to select and recommend a panel of names to fill up the Member post vacant in the Tamil Nadu Electricity Regulatory Commission.
