From the Secretary (i/c), Tamil Nadu Electricity Regulatory Commission, Letter No.816/TNERC/Admn/D.No.815/2022, dated 18.5.2022 and 27.5.2022.

ORDER:-

In the letters read above, the Secretary (I/c), Tamil Nadu Electricity Regulatory Commission has stated that as per the instructions issued in Government Lr.No.2155/FS/T/2020, Finance (BPE) Department dated 27.10.2020, appointment of retired Govt. employees or retired officials from other Public Sector Undertakings/Statutory Boards on contract basis shall not be made without the specific approval of the Government. He has stated that the approval of the Government is necessary to fill up the post of Secretary in Tamil Nadu Electricity Regulatory Commission on contract basis, which fell vacant from 12.05.2022 with the qualification and experience prescribed in G.O.(Ms) No.80, Energy (A1) Department, dated. 19.08.2002. The initial process of issuing notification, calling for applications and selection formalities has been started simultaneously by the Tamil Nadu Electricity Regulatory Commission pending concurrence of the Government.

2. Accordingly, the Commission had notified the post of Secretary to be appointed on contract basis and had issued an abridged version of Employment Notice in The Hindu (Tamil Nadu Edition) and in Daily Thanthi (Tamil Nadu Edition) on 6th April 2022 and also hosted the detailed Employment Notice in the website of Tamil Nadu Electricity Regulatory Commission www.tnerc.gov.in fixing the last date for receipt of applications on 27th April 2022. The Commission on 12.04.2022 had approved a criteria of Evaluation based on the qualification and experience required for the post of Secretary as per G.O.(Ms) No.80, Energy (A1)

Department, dated 19.08.2002 and the Commission had formed an Evaluation Committee to evaluate the applications to be received.

- 3. Secretary(i/c), Tamil Nadu Electricity Regulatory The Commission has also informed that the Commission had received ten applications for the post of Secretary on contract basis. Based on the information furnished by these ten applicants, the Evaluation Committee had disqualified seven applications which did not adhere to the notification i.e., Employment Notice. As per the criteria of Evaluation dated 12.04.2022, the Evaluation Committee awarded marks for the remaining three applications and they were called for an interview before the Selection Committee. The Selection Committee comprising the Chairman and Director (Tariff) conducted an interview on 18th May, 2022. Based on the marks awarded by the Evaluation Committee and based on the marks awarded by the Selection Committee, Dr C. Veeramani, formerly Chief Engineer (Mechanical), Regulatory Cell, TANGEDCO was selected for the post of Secretary in Tamil Nadu Electricity Regulatory Commission on contract basis.
- 4. The Secretary (i/c), Tamil Nadu Electricity Regulatory Commission has certified that Dr C.veeramani has fulfilled the qualification and experience prescribed for the post of Secretary as per G.O.Ms.No.80, Energy (A1) Department, dated 19.08.2002 to be appointed on contract basis. He has therefore requested the orders of the Government for appointing Dr C.Veeramani, as Secretary in Tamil Nadu Electricity Regulatory Commission on contract basis for a period of three years from the date of appointment since the individual will be attaining 65 years of age on 4.5.2025 as per clause 5 (Age) of the Employment Notice dated 6th April 2022.
- 5. The Government, after careful consideration, have decided to grant its approval for the appointment of Dr C.Veeramani, formerly Chief Engineer (Mechanical), Regulatory Cell, TANGEDCO for the post of Secretary in Tamil Nadu Electricity Regulatory Commission on contract basis and order accordingly.
