ORDER:-

In exercise of the powers conferred under Sub-Section (4) of the Section 166 of the Electricity Act, 2003 the Government have issued orders in the G.O first read above, reconstituting the State Coordination Forum for smooth and Co-ordinated development of the power system in the State. The above Forum had been reconstituted with the Chairman, Tamil Nadu Electricity Regulatory Commission as the Chairperson with the following members:-

- Members of the Tamil Nadu Electricity Regulatory Commission.
- (ii) The Chairman, Tamil Nadu Electricity Board.
- (iii) The Chairman, Neyveli Lignite Corporation.
- (iv) Member Secretary, Southern Regional Electricity Board.
- (v) Director (Operations), Power Grid Corporation of India Ltd.
- (vi) Member (Planning), Central Electricity Authority, New Delhi.

- (vii) Thiru D.V.Giri, President and Chief Executive Officer, Pioneer Wincorn Private Limited.
- (viii) Managing Director, GMR Energy Sector.
- (ix) Secretary, Energy Department of the Government of Tamil Nadu.
- (x) Chairman & Managing Director, Tamil Nadu Energy Development Agency.
- 2. To meet the requirements on the Electricity Act 2003 the Government in G.O.Ms.No.114, Energy (B2) Department, dated 8.10.2008 have accorded approval for formation of a holding company, by name TNEB Limited and two subsidiary companies namely Tamil Nadu Transmission Corporation Limited (TANTRANSCO) and Tamil Nadu Generation and Distribution Corporation Limited (TANGEDCO). The Government in G.O.(Ms.)No.103, Energy (B2) Department, dated 11.12.2009 and G.O.(Ms.)No.36, Energy (B2) Department, dated 5.4.2010 have posted Chairman-cum-Managing Directors & other officials for TNEB Ltd., TANGEDCO and TANTRANSCO. The holding company viz., TNEB Ltd., TANGEDCO and TANTRANSCO have come into existence with effect from 1.11.2010.
- 3. Now the Secretary, Tamil Nadu Electricity Regulatory Commission has submitted that the Chairman, Tamil Nadu Electricity Board has already been nominated as one of the Members of State Coordination Forum to represent the power utilities engaged in Transmission and Distribution in Tamil Nadu. In view of formation of separate entities viz., TNEB Ltd, TANGEDCO and TANTRANSCO., the Commission desires the following changes in the State Co-ordination Forum:-
 - To delete the Chairman, Tamil Nadu Electricity Board from the list of Members of the State Co-ordination Forum and
 - (2) To include the following as the Members of State Coordination Forum:-
 - a) Chairman-cum-Managing Directors of TANGEDCO and TANTRANSCO.
 - b) Managing Director of TANTRANSCO.

- 4. The proposal of the Tamil Nadu Electricity Regulatory Commission was examined in detail and the Government hereby order the following changes to the State Co-ordination Forum:-
 - To delete the Chairman, Tamil Nadu Electricity Board from the list of Members of the State Co-ordination Forum and
 - (2) To include the following as the Members of State Coordination Forum:-
 - a) Chairman-cum-Managing Directors of TANGEDCO and TANTRANSCO.
 - b) Managing Director of TANTRANSCO.
