**ORDER:**

In the Government Order first read above, the Tamil Nadu Electricity Regulatory Commission, was formed with Chairman and two Members. The Commission is now fully functional. Of the two Members, one Member Thiru B.Jeyaraman, Member, Tamil Nadu Electricity Regulatory Commission appointed in the Government Order second read above , will be completing five years of term of office on 29.6.2009 since he took charge on 30.6.2004. So, one post of Member will fall vacant from 30.6.2009 Fore Noon.

As per sub-section (1) of section 85 of the Electricity Act, 2003 (Central Act 36 of 2003) a Selection Committee has to be constituted by the State Government for selecting the Members of the State Electricity Regulatory Commission.
