ORDER :-

In the Government Order first read above, orders were issued for the formation of the State Electricity Regulatory Commission under the Electricity Regulatory Commission Act, 1998 (Central Act 14 of 1998) and among others the pay of the Chairperson and Members have been fixed as Rs.26,000/- and Rs.24,500/- p.m. respectively. Subsequently in the Government Order second read above, necessary amendment has been issued to the effect that the conditions, of service and other perquisites available to the Chairperson shall be the same as admissible to a serving Judge of a High Court.

2) Consequent on the revision of scale of pay of All India Services Officers by the Government of India following the recommendations of the Sixth Central Pay Commission, the Chairman, Tamil Nadu Electricity Regulatory Commission in the reference fifth read above has requested to revise the Fixed Pay of the Chairman and Members of the said Commission from Rs.26,000/- to Rs.80,000/-p.m. and from Rs.24,500/- to Rs.79,000/- p.m. respectively.

3) After careful consideration, Government has decided to revise the scale of pay of the Chairman and Members of Tamil Nadu Electricity Regulatory Commission. Accordingly, Government direct that the Fixed Pay of the Chairman and Members of Tamil Nadu Electricity Regulatory Commission shall be revised as given below:

4) The above revision of Fixed Pay of Chairman and Members of Tamil Nadu Electricity Regulatory Commission shall take notional effect from 1st January, 2006 with monetary benefit from 1st January, 2007. The arrears of pay shall be paid in three equal annual instalments after deducting the Interim Arrears paid to them i.e. first instalment in the year 2009—10, second instalment in the year 2010—11 and final instalment in the year 2011—12. The other entitlements shall continue to be governed by the Rules stipulated in the Government Order first read above.
