New Health Insurance Scheme - Extension of the scheme to willing institutions - Orders - Issued.

## ORDER:

In the Government Order seventh read above, it has been ordered among other things that the employees of certain categories of organisations which are willing to bear the employers' share of the premium and are willing to collect the employees' contribution and where there is no financial liability befalling on the State Budget may be included under the coverage of the New Health Insurance Scheme.

- 2.The Tamil Nadu Electricity Regulatory Commission has sent specific proposals for extension of the coverage of the New Health Insurance Scheme to their employees and have furnished their willingness to contribute the employers' share of the premium payable to the insurance company as per the provisions of the scheme.
- 3.It is hereby ordered that regular employees of the Tamil Nadu Electricity Regulatory Commission be covered under the New Health Insurance Scheme with immediate effect. The orders issued under the New Health Insurance Scheme shall be applicable to the employees covered in this order. The Secretary, Tamil Nadu



Electricity Regulatory Commission shall arrange to upload the details of the employees covered under the scheme on the web-site of the Treasuries and Accounts Department viz. http://www.tn.gov.in/Karuvoolam.

4. The New Health Insurance Scheme has commenced from 11.6.2008 and the period of the scheme ends on 10.6.2012. As per the orders issued in para 4 of the Government order second read above the total annual premium (the employees' subscription and the employer's contribution and the tax amount) for the current year has to be paid in advance by 1.10.2009 on pro-rata basis i.e. for the period from 1.09.2009 to 10.6.2010. For the ensuing years the premium has to be paid within one month of commencement of that particular year under the scheme (i.e.) before 11<sup>th</sup> of July to the following sub head of account.

- 5. The Commissioner of Treasuries and Accounts shall be the estimating, reconciling and controlling authority in respect of the head of account mentioned above. The Commissioner of Treasuries and Accounts shall reckon the employees covered under this Government Order also while sending proposals based on the number of Identity Cards for sanction of release of premium amounts due to the insurance company from time to time.
