NOTIFICATION OF WAR BURNEY OF THE WAR AND THE WAR AND

In exercise of the powers conferred by clause (a) of subsection (2) of section 180 read with sub-section (1) of section 15 of the Electricity Act, 2003 (Central Act 36 of 2003), the Governor of Tamil Nadu hereby makes the following Rules:-

THE RULES THE GOOD AND ASSESSED AND

- Short title and commencement: (1) These rules may be called the "Fees for Making Application for Grant of Licence Rules, 2007.
 - (2) They shall come into force at once.
- 2. <u>Definitions:-</u> (1) In these Rules, unless the context otherwise requires,-
 - (a) "Act" means the Electricity Act, 2003 (Central Act 36 of 2003);
 - (b) "section" means a section of the Act;

- (2) Words and expressions used and not defined in these rules but defined in the Act shall have the meanings respectively assigned to them in the Act:
- 3. Fees for making application for grant of licence:- Every application under section 14 for grant of licence shall be accompanied by a fee of rupees one lakh in the form of demand draft drawn in favour of the Secretary, Tamil Nadu Electricity Regulatory Commission, payable at Chennai.
