ORDER:-

In the Government Order first read above, orders were issued constituting the Selection Committee to select the Chair person of the State Electricity Regulatory Commission with the following members:-

2. In the Government Order second read above, Orders were issued to allow Thiru A. Balraj, Chairman, Tamil Nadu Electricity Regulatory Commission to opt for the conditions under Electricity Act, 2003 and to retire on 6.7.2006 A.N. consequent on the retirement of Thiru A. Balraj, the post of Chairman, Tamil Nadu Electricity Regulatory Commission fell vacant from 7.7.2006. In order to fill up the vacancy the Selection Committee recommended a panel of names for the said vacant post. The Government have carefully examined the recommendation of the Selection Committee and decided to appoint Thiru S. Kabilan, I.A.S., as Chairman, Tamil Nadu Electricity Regulatory Commission.

In exercise of the powers conferred by sub-section (5) of section 82 of the Electricity Act, 2003, (Central Act 36 of 2003) and on the recommendation of the selection committee referred to in section 85 of the said Act, the Governor of Tamil Nadu hereby appoints Thiru S. Kabilan, I.A.S., as Chairman, Tamil Nadu Electricity Regulatory Commission.
