**In the matter of : Additional Tariff subsidy for FY 2024-25 due to the Revision of Tariff w.e.f 01-07-2024 based on the Tariff Order No.6 of 2024 dated 15-07-2024 by the Government of Tamil Nadu.**

---

The Commission has made an amendment in Regulation 3(1) of the Terms and Conditions for Determination of Tariff for Transmission and Distribution of Electricity under MYT framework Regulations, 2009. In the aforesaid regulation, the control period has been amended as 5 years instead of 3 years.

2) The Commission, in its Tariff Order No.7 of 2022 dated 09-09-2022, has stated that the applicable tariff for ensuing years of control period shall

be as per prevailing tariff x (1+(CPI of April of respective financial year – CPI of April of previous financial year)/CPI of April of previous financial year) or 6% whichever is lower with effect from 1<sup>st</sup> July of respective year

3) The Commission hereby applies the following rate of escalation, based on CPI for the FY 2024-25 as follows:

The Commission had applied the rate of 4.83 % for both energy charges and fixed charges, to arrive at the new Tariff Schedule.

4) The Government of Tamil Nadu, Energy Department, in its letter No.4488/D3/2024-1 dated 15-07-2024, has issued a commitment letter for additional subsidy by way of policy directive under section 108 of the Electricity Act, 2003. The GoTN will compensate to TANGEDCO the increase of 4.83% on existing subsidy from 01-07-2024 onwards in addition to the existing subsidy in respect of LT Domestic, Handloom, Powerloom, Actual places of Public Worship, Agriculture (Normal), Agriculture (SFS), Hut, LT Industries (peak hour ToD & Network charges), Common supply and HT Lift Irrigation categories of consumers.

5) TANGEDCO, in their letter No.CFC/RC/FC/DFC/RC/F.Subsidy/D.No.497/24 dated 29-07-2024 has requested the Commission to issue the additional subsidy order in consonance with the tariff revision considered in the Suo-Motu Tariff Order No.6 of 2024 dated 15-07-2024 for the categories mentioned in the Government letter cited above.

6) Due to the revision of tariff, the additional Subsidy payable by GoTN to TANGEDCO for the period from 01-07-2024 to 31-03-2025 for different category of consumers is as follows:

b) The Commission has made an amendment in the Procedure for payment of subsidy by the State Government Regulations. Therefore, GoTN is advised to release the aforesaid additional subsidy amount proportionately, before the commencement of every quarter for all categories of consumer.

**Directives:**

i) The Government of Tamil Nadu shall provide the above subsidy in advance to compensate the shortfall in revenue to TANGEDCO

consequent to the extension of free supply/ reduction of tariff as per the policy direction.

- ii) The TANGEDCO shall extend free supply / collect reduced tariff as per the policy directives of the Government of Tamil Nadu.
- iii) The Government of Tamil Nadu as well as the TANGEDCO will have to abide by the provision under Section 65 of the Electricity Act, 2003 which reads as below:

*"Provided that no such direction of the State Government shall be operative if the payment is not made in accordance with the provisions contained in this section and the tariff fixed by the State Commission shall be applicable from the date of issue of orders by the Commission in this regard."*

- iv) The TANGEDCO shall reconcile the subsidy allowed with the actual consumption and revenue assessed during the 1<sup>st</sup> quarter in FY 2024-25 and furnish the report within 60 days as stipulated in the regulation.
- v) While furnishing the actual consumption details, it should be ensured that slab-wise consumption is furnished correctly.
- vi) It should be ensured that the details are furnished by the Chief Engineers uniformly in the same format.
