Tamil Nadu Electricity Regulatory Commission (TNERC) is a statutory body constituted by the Government of Tamil Nadu in accordance with the Electricity Act, 2003 and is located at Chennai. It is vested with powers to determine the electricity tariff, regulate electricity purchase and procurement process, issuing licences, facilitate intra-state transmission and wheeling, promote cogeneration, specify State Grid Code, specify or enforce standards of performance and adjudicate upon disputes. The Commission shall be guided by the National Electricity Policy, National Electricity Plan and Tariff Policy published under section 3(2) of the Electricity Act, 2003.

The Commission desires to fill up one post of **Deputy Director (Legal)** on Deputation basis on Foreign Service terms from the Officers of Central/State Governments, Public Sector Undertakings, Autonomous Bodies and All State Electricity Regulatory Commission.
